The weather last week demonstrated the problem with flash flooding. The storm delivered 25mm of rain in an hour. The maintenance work has again proved very effective in reducing the flood risk. Had that storm lasted another hour then the situation may have been very different. This is a timely reminder that we need to progress and deliver the scheme to protect properties.

Property Protection scheme

Thank you to Cllr Kettle who has escalated concerns over the solutions where large lengths of barriers are proposed. When would barriers need to be deployed and the practicality of installing in adverse weather conditions. Meeting to scheduled for end of June/early July

- Non-listed properties

Out of the 15 agreements issued thus far to non-listed properties looks like at least 10 will proceed. The level of drop out is disappointing but householders have had a choice.

- Listed properties
- 8 agreements still to be issued.

There has also had one withdrawal.

Ongoing liaison with Stratford District Council regarding the LBC application when the survey results and design information is available to submit. However, it is anticipated legal agreements will then be issued shortly.

WHC were looking into locations within the village for welfare facilities and compound.

Memorial Road

The Flood Risk team have been chasing the Highways team for some time in regard to the flooding matters on Memorial Road, however they still do not have the capacity to come out on site. As this matter has been ongoing for considerable time the flood risk team have made the decision to have the site surveyed regardless.

They have been in contact with the company that surveyed the system back in 2017 and have reviewed the report. WCC are hoping to have the network beneath Memorial Road jetted and re-surveyed in July/August. Timing is somewhat limited due to it being in close proximity to the school, therefore we will book it for outside

Division issues Warwickshire Highways have confirmed that owing to issues of environmental health with the piling operation, there are delays to the Fosse Way / Harbury project.

Road closures are arising from the movement off site of Dorothy the HS2 tunnel boring machine from Ufton To the M40 junction 12.

The Fenny Compton speed limit and vehicle survey on Wharf Road and Station Road have demonstrated a need to extend the 30 mph to beyond the entrance to the Homes England with a proposed 40 mph upto the A423.

Flooding The challenges of the flooding protection scheme has been raised with WCC flooding team again and an onsite meeting is being arranged.

Councillor Grant Fund The first window has now closed for the WCC Councillor Grant Funding. As part of the 23/24 budget this amount has been increased to £8,000 per County Councillor.
