IN ATTENDANCE: Cllr Nigel Rock (Stratford District Council (SDC)), Cllr Bob Stevens (Warwickshire County Council) (WCC)), Parish Clerk Ian Wilson and one member of the public.

1 Apologies

Apologies were received from Derek Carless and were accepted.

2 Acceptance of Minutes of Previous Meeting

The Minutes of the Ordinary meeting on 9th December 2019 (already circulated) were considered and the minutes were **agreed**.

3 Declarations of Interest

Alan Payne declared an interest in discussions and correspondence around HS2.

4 Requests for Dispensation

There were no requests for dispensation.

5 Open Forum

An update on the Compton Buildings development was discussed. It was noted that Homes England were moving towards appointing a contractor and will then proceed with a planning application. The planning application and conditions could consider extending and improving the pavement and would revisit and review the speed limit by the site.

A resident informed the parish council that he had sent a formal complaint to SDC Chief Executive and leader of the Council regarding the recent consultation exercise on plans by SDC to charge for collecting green waste. It was noted that the majority of residents responding had opposed the charge. However, SDC still intended to introduce the charge for 2020/21. The complaint had tried to be constructive and had raised issues not covered in the consultation such as the cost of monitoring other SDC 'free refuse collections' to ensure green waste was not being included. The Parish Council had been copied into this complaint and a response was now awaited. The meeting discussed the consultation and noted that while the consultation had not been as extensive as it could have been, the reason for introducing this charge seemed to be for SDC to raise revenue for a non-statutory service and avoid having to cut other statutory services further.

6 Matters Arising from Previous Minutes

Speed Data – Noted that CLLR ROCK had received the information from satellite navigation providers. However, this didn't really provide a quick insight as evidence as to whether the speed limit by the railway bridge was too high. It was suggested that this matter should be reconsidered as part of the planning application for

Planning - Hornbeam application (19/03267/FUL) was now with SDC planners for consideration.

Defibrillator – Cheque from Parish Council now with GP surgery to fund the defibrillator.

Village Bus Stop – This appears to be used for school journeys, it appears structurally sound with the main problem being the urgent need to repair the roof. The cheapest prices found for replacement shelters were around £1700 and it was therefore **agreed** that the clerk would ask the handyman for a quote to repair the roof on the existing shelter.

Planning Process – No issues identified with SDC planning processes for CLLR Rock

Grass Cutting – Clerk is awaiting quotes for the cost to cut the grass owned by Orbit housing by Berry Meadow and Grants Close. He would also liaise with the handyman to determine which bits were currently being cut by the garages and elsewhere.

9 Reports from WCC and SDC representatives

CLLR Stevens reported on behalf of WCC (report attached). The County Council was currently planning for 2020/21 and beyond taking account of the effect on local government of UK withdrawal from the EU, further constitutional and local government reform was likely to be on the agenda. Locally education would probably move to more multi-academy trusts of schools. Warwickshire is still considered a good place to live according to national comparators. CLLR Stevens noted the recent discussions on flooding and would endeavour to ensure that an officer from the County Council could attend a future meeting.

CLLR Rock reported that SDC will implement charging for Green Waste collection in 2020. The formal settlement from central government for 2020/21 amounted to £9.33m and SDC needed to find savings and revenue to maintain services, budget proposals with a small increase in SDC element of the council tax would be put out to public consultation in February before the budget and council tax requirements were agreed by SDC. As previously reported SDC was working to develop actions

to respond the Climate Change Emergency, one of these measures included extra green requirements as part of planning considerations and again this was open for consultation during February

10 Financial Administration

The meeting received the latest budget report for December and the proposed budget for 2020/21 (attached). The meeting discussed the proposed budget and **agreed** that the precept submitted to SDC should therefore be £24510.80

It was **agreed** that the Parish Council printer should be publicised as being available to the community in the next Parish newsletter.

11 Updates

Flood Prevention – Alan Payne referred the meeting to his earlier e-mailed reports (attached). The meeting noted that the last quarter of 2019 had been the wettest quarter of the decade. As yet there had been little response from WCC flood team and Alan Payne would draft a letter with CLLR Stevens to WCC officers requesting an update. In the village recently the group had looked at the Ridgeway development and CLLR Rock had been able to provide an update from SDC planners on enforcement action underway with the developers. Surface water in the development was currently being pumped back into the system and a drainage ditch was blocked. It was proposed and **agreed** to spend £200 from the Parish Council flood reserve to undertake flood alleviation measures after consultation with landowners. A stock take of sand bags would also be carried out.

The meeting also discussed flooding on the highway by Compton Buildings and it was agreed that CLLR Rock would liaise with CLLR Stevens so that WCC Highways could work with Homes England to alleviate this.

Neighbourhood Plan – Michael Guest reported that the final draft of the plan had been passed to the planning consultant for pre-screening. There would be some minor redrafting before this could go to government consultees, such as Natural England. Following the next meeting of the group the plan could go to statutory consultees and then in March for six week public consultation.

Allotments – The next step is to agree roles and responsibilities between the Parish Council and the management committee, guidance has been sought from the

Street lighting – The meeting discussed streetlights that hadn't yet been adopted and whether these should be included in the Parish Council inventory for future budgeting

GDPR – Nothing to report

Traffic Calming – The Parish Council had previously received proposals for Church Road, looking to alleviate congestion by the school and 'Give Way' at the Merrie Lion, particularly a deterrent to stop vehicles going the wrong way. It was **agreed** to spend £500 for WCC Highways to draw up plans for a scheme the Parish Council could then consider.

Highways – Potholes reported to WCC Highways

Playing Field & Equipment— Ian Hartwell was obtaining quotes to repair the cable slide and reported that more garage doors were now detached. Jon Dutton would again raise with the Colts what needed to be done with the garages by the playing field. Swing replacements were still to be considered for the playground, though there may be a possibility of some grant funding for this for WCC wellbeing fund.
