- Consultation on Proposed South Warwickshire Council
 - Local Government is facing a very uncertain time. Funding for the sector especially District Council's has been significantly reduced and following the impact of COVID pandemic it is estimated that there once more could be further reductions. At the same time the cost of delivering valued services is increasing, this is particularly the case in relation to the refuse and recycling service
 - Faced with these pressures the elected members of both Councils agreed earlier this year to explore the principle of Stratford-on-Avon District Council and Warwick District Council to formally merged, and agreed the following vision:
 - "To create a single statutory South Warwickshire Council covering all of the activities currently carried out by Stratford-on-Avon District Council and Warwick District Council by 1 April 2024."
 - In order to achieve this vision by April 2024, a formal submission to request a merger has to be made to the government by the end of the year. In making any submission the Councils will need to demonstrate that the proposals address the following:

There are still concerns over the capacity/maintenance of the surface water system in Memorial Road and the Ridgeway. Also local concerns about the impact of the new houses on The Lankett, and ditch clearance on the Avon Dassett Road

Appendix C - District Councillor for Napton and Fenny Compton Report

There are two consultations this autumn and both affect how we are to be represented.

Firstly, a review of the present District Council Ward Boundaries was started some time ago - well before talk of a merger with Warwick District. Secondly the consideration of that merger is to be the subject of a comprehensive public consultation.

District Council Ward Boundaries. Presently there are 36 councillors, down from the 53 there were 10 or so years ago. Broadly, each councillor represents a 'Ward' area of about 2600 electors now, whereas it was 1800 before. There were a number of concerns that the earlier reduction in councillors was too great, resulting in poorer representation, and wards that are too big, with excessive activity that varied widely between wards. The proposed reorganisation is intended to produce an increase to about 41 councillors. The Boundary Commission has published proposals for public comment between now and 8th November 2021. I would encourage everyone to read what is intended and comment upon it. It is on the Boundary Commission's web site: www.lgbce.org.uk (Select Stratford on Avon Council.)

There are many aspects to the report, but for us, I have great concern for our area's representation. We already have the largest ward in the District, and I am not happy with the outcome. In overall terms this proposal makes matters much worse, with a new giant ward that stretches to Shuckburgh in the North East, Shotteswell in the south, and the M40 Junction at Gaydon in the west. This giant ward would have two councillors instead of one.

Given the objective of the review - to make better democratic connections, ease and even out workload etc, one wonders what has gone wrong. The report looks for comment from residents on community and public communications with the councillors that might represent you in the future.

District Council Merger. A decision whether or not to ask to government to permit the merger of Warwick and Stratford will be taken by the two Councils in December. To inform those taking the decision, (which is the councillors of both Warwick and Stratford) information has been published and a consultation will run until 24 October 2021. I would also encourage people to review this. One linkage with the previous part of my report above is that these proposal as put forward will also increase the size of wards that District councillors are to represent. However there are many other significant matters to consider which are set in a comprehensive information pack. I have been asking the Council to put more information out other than on web sites but see: www.southwarwickshire.org.uk I would appreciate hearing people's comments directly as well.

Road Closures – HS2 There are to be some road closures by HS2 between Priors Hardwick, Wormleighton and Boddington in the next few weeks. Whilst this is nothing like the scale and duration of road closures by the polo ground, if you use these routes they are important to you of course. There will be intermittent closures, between 27 September and 19 November, 09.30am to 3.30pm. More information is set out in the link below. The County Councillor and I pressed the contractors on their thinking on every respect of their plan - I was concerned that this will direct more traffic through unsuitable village routes. Mainly the work involves tree felling and activity to protect wildlife. Whilst I would rather they were not felling any trees anywhere (nor indeed building HS2) if it is to be done, this work to protect the species is important and time critical.

Appendix D: WARWICKSHIRE COUNTY COUNCILLOR'S REPORT - Feldon Division

COVID19

The rate of infections rate for the Feldon Ward is 235/100,000 compared to a Stratford District rate of 263/100,000 a decrease from 308 last week. To the west rates are lower being less than 200 but to the East, Dunchurch, parts of Warwick and south over the Northampton border rates are all above 400. The over 60's rate has increased to 115/100,000 (105 last week) with 84 cases over the last seven days in Stratford District. Other districts rates in Warwickshire per 100,000inre: Nuneaton & Bedworth 444, North Warwickshire 371, Warwick 323 and Rugby 420.

There has been one further Covid related death across Stratford District (total now 305). Ther are ten patients in hospital in SW NHS foundation Trust.
