2	Review action points from 30 May JW confirmed that survey monkey has a feature called 'question logic' that allows respondents to skip questions that are not relevant. JW agreed to set this up in main survey as required. Voluntary groups to consult – we can use the list on the back of the Compton Chronicle. HB unable to organise Tysoe contact to talk to Group due to injury.	JW
3	Correspondence – SDC built-up area boundary The Group considered the BUAB identified by SDC. The Group agreed that it was accurately drawn according to SDC's methodology. DC to ask SDC for clarification on the status of peripheral built-up areas from The Wharf down to Compton Buildings and at the top of Fenny Compton hill. [Also see action under item 5E] The Group expressed concerns that the BUAB might be at odds with the reasons for refusing the development next to Thomsons Field, where the proposed Compton Buildings development fulfils the village's Core Strategy allocation. 4	Clarification from SDC policies versus projects SDC has clarified that the Neighbourhood Plan should focus on development and land use. Everything else is outside the scope of the plan. Projects are useful, but also outside the scope. However, traffic concerns are within the remit of the Parish Council. MG said that the Parish Council has £2,635 for traffic management. DC agreed to draw together concerns expressed in the NP initial survey for the Parish Council and talk to WCC Cllr Bob Stevens.	DC
