


Appendix C - District Councillor for Napton and Fenny Compton Report

Covid Rates Over recent weeks Covid infections in the District as a whole have been higher than they have ever been, but are now starting to fall back from around 500 per 100,000 a week ago, to below 400. The areas in the east of Stratford District have been almost double these rates and, for reasons not clear, our local areas have been something of a hotspot, but here too the numbers have reduced from the very high infection rate we saw. This was at odds with previous experience where our rural areas tended to be lower

Whilst the majority of cases are still in school age children there have been increasing numbers in the over 60s which is a particularly vulnerable group. Personally I am perplexed by the Government's messaging that even minor controls (such as mask wearing in shops) are not needed, because it seems that many people think the pandemic is more or less over. A slight fall does not take us back to where we have been

Boundary Review & Merger Work on the potential merger between Stratford and Warwick District Councils has been continuing and the consultation has now closed. A representative sample of residents has been contacted for their opinions, and an analysis of responses is underway. Meanwhile, there are Boundary Commission proposals for changing council ward boundaries if no merger takes place. The Commission's proposal involves a mixture of single councillor wards and wards shared between councillors, as well as some strange looking boundaries

At a series of meetings, Stratford Council has resolved to resist the Boundary Commission proposals in a couple of key matters: 1. that the Boundary Commission have not respected the Council's wish for single member wards, and 2. that the very large two-member ward the Commission proposed from the M40 to Shuckburgh is not acceptable

The date for responses to the Commission has been extended to 6th December

The Council went on to unanimously agree a way that overcomes both issues. I had considerable input to that response. No one thinks the choices are entirely satisfactory being driven by numbers rather than communities. Getting the same number of electors for council wards around Southam is impossible while keeping to Southam parish boundaries, so there have had to be some compromises. The Council's response

It's worth saying there are two parishes in my present ward which I am not completely happy about in the Council's response to the proposals, but the numbers cannot be made to work otherwise. It would have been preferable to keep Wormleighton the same Ward as the Priors and Ladbroke would probably be better with Harbury rather than Bishops Itchington

However if the merger of Stratford and Warwick happens – we will have to start again!

Planning Enforcement There has been a restructuring of the team that deal with suspected infringements of the planning regulations, which has been an area of some concern for a while. It has taken months if not years to investigate cases. It is in everyone's interests to understand whether planning rules have been broken as soon as possible and two new enforcement officers have joined the team. If residents are unsure about whether permission is needed, the duty planning officer may be able to advise 01789 267575. If a breach of planning control is suspected it can be reported at: planning.enforcement@stratford-dc.gov.uk

Nuisance Lighting I have had complaints about nuisance lighting from HS2 and other properties. There a number of controls that can be applied but environmental health at Stratford is the first point of advice if it affects a residence. I am discussing HS2 depot lighting with their contractors

NDP I asked a formal question (see appendix) at the full council meeting in an attempt to clarify the position of Neighbourhood Plans. The intent of these plans is that they give maximum say to local communities in planning decisions. It seems that this is not working out as I would have wished. I append the formal response. I was surprised to find the old parish plans were not automatically extinguished by the Neighbourhood Development Plan, something that had not been made clear to parishes

Councillor Rock asked:

This Council has encouraged and approved the 'making' of a significant number of Neighbourhood Development Plans (NDPs). Such Plans have been through extensive public examination to ensure they are in conformance with national and local policy and when 'made' form part of the Core Strategy.

Would the Portfolio Holder agree that local provisions and policies in such NDPs cannot be overridden in determining applications by lesser weight documents with a less rigorous examination process? Would he also agree that Government statements requiring general provision to be made by local authorities, for example for self and custom-built homes, do not override local NDP policies where these are not in conflict?

The Neighbourhood Development planning process has replaced the Parish Planning process. Prior to referendum stage, NDPs are rightly given increasing weight as they take over and replace any Parish Plan for the area. When 'made' the NDP becomes the definitive planning document for the locality. It seems axiomatic that the superseded Parish Plan is extinguished, unless there is a good reason otherwise.

Is there a process for extinguishing the Parish Plan that has been superseded? Would the Portfolio Holders agree that old, outdated and superseded Parish Plans should not be used to determine applications where they have been superseded by 'made' NDPs for the same locality?

Would the Portfolio Holders agree that NDPs should be given due weight and primacy in the planning system and by Planning Committees?

Councillor Pemberton (Portfolio Holder for Place and Economy) responded as follows:

To clarify the status of Neighbourhood Development Plans (NDPs). Once they are 'made' they form part of the Development Plan for the District and, as such, are given due weight and primacy in the planning system and by the Planning Committee. They hold more weight in the decision-making process than some other documents such as Supplementary Planning Documents and Parish Plans. They, along with the Core Strategy, form the starting point for the determination of applications unless material considerations indicate otherwise. Whilst not part of the statutory Development Plan, other documents (e.g. Supplementary Planning Documents, Parish Plans, emerging local plans, NPPF etc.) can be considered to be a material consideration. Indeed, depending on what a Parish Plan says, it could still be a useful source of guidance for decision-makers, especially if the NDP is silent on a particular matter.

It is important to note that NDPs do not replace Parish Plans. They are different types of planning documents, with NDPs being policy documents and Parish Plans principally providing action plans for local projects. There is a role for both types of document within the existing planning process. As such, once an NDP has been 'made' for an area, it does not supersede any existing Parish Plan for the area, this would remain in place as a material planning consideration. The Parish Council may revise or withdraw a Parish Plan if they so wish which, for example, it is deemed out of date or if all the actions/projects listed have been completed. It is for the Parish Council to notify the District Council if they wish to pursue this course of action.

A key point to bear in mind is that if an NDP is silent about a particular issue, such as providing for self and custom build homes, as with the Core Strategy, the National Planning Policy Framework (para. 11) makes it clear that, where there is no policy in a Development Plan relating to a specific form of development, planning permission should be granted unless there is a clear reason for refusing the proposed development as its adverse impacts would outweigh the benefits.

In a supplementary Question Cllr Rock asked if Parishes should be advised that Parish Plans will continue in force unless otherwise requested at the time an NDP was 'made'. The Portfolio Holder agreed to examine this idea.
