Appendix C – District Councillor Report

Local Government Re-organisation: As we have reported previously, and elsewhere, the government has decided to merge the functions of the District and County Councils into a Unitary Authority. Although central government will make the final decision as these changes are being considered, it is important that residents have a say in the future of their local councils. More information is available on the District Council's website – just click on the link if reading in electronic form: [Reshaping our Councils for the future of Warwickshire](#)

There are two alternatives under consideration: to merge all six local councils (Warwickshire County, Stratford, Rugby, North Warwickshire, Warwick, Nuneaton & Bedworth) into one across Warwickshire - or – to have two 'unitary' councils, which in our case would mean covering Stratford and Warwick District areas with a new South Warwickshire council.

The [Deloitte report](#) (on SDC's website) evaluates the two proposals which were identified by Stratford Council in the "interim plan" in March and concludes that a *two-unitary model* emerges as the most advantageous structure for Warwickshire.

Whilst there are arguments both ways, on present knowledge we believe that a South Warwickshire Council (est pop 295000) would be the best for our residents. Those in favour of a large whole Warwickshire (est pop 617000) solution argue it will be a difficult transition to split up the big spending services such as social care, fire, highways and education (even though some of these are already organised on a district area basis). It is our view that as a principle, local government should be local, and the council taxpayer will be financially and democratically better served by a smaller unitary council. At its simplest there would appear to be lower council tax in the South Warwickshire proposal, and less remote services including better councillor representation ratios.

Housing Numbers: As previously reported, there have been challenges underway to the District's five-year land supply following the change to the national planning framework. The Government's new rules increased the house numbers required and also the method of calculation. Stratford District had been well ahead in housing numbers, until this change, at about 25 years housing supply. A public enquiry on 4 September at Bordon Hill near Stratford re-examined the District's new figure of 5.06 years. The appeal hearing came out with a ruling that we're now down to 2.74 years supply, well under the 5-year requirement; this has significant implications.

The area is now at risk of more housing being added to the outside of settlements across the area. Unsuitable housing applications that should be refused because they go against our local policies, may now have to be permitted just to get overall numbers up.

As a result, SDC are looking at all the options to bring our supply back up to 5 years: using reserve sites, bringing empty homes back into use, and pressing developers to implement their permissions instead of land banking, which is a big part of the reason we are in this situation.

Severn Trent: Severn Trent have organised a meeting with environment groups across the wider area of South Warwickshire on the issue of foul discharges. This took place at Wellesbourne on 21 August. As well as those resident groups, Natalie, Nigel and several other SDC councillors plus Stratford MP Manuella Perteghella were there to raise questions. These covered not only the spill history, but planning for the future. We were promised follow-ups, but specifically we have asked for improved liaison between the District Council and Severn Trent on infrastructure planning.

Community Climate Change Fund: Round Three remains open for applications. There is no deadline as applications will be assessed on a quarterly basis, meaning applicants will have to wait a minimum of three months to be informed as to whether they have been successful or not. Warm Homes: Despite the recent warmer weather Stratford-on-Avon District Council is thinking ahead to the cooler months and is pleased to announce a new funding scheme available to residents to help keep homes warm and reduce the cost of energy bills.

The Warm Homes Local Grant (WHLG) is primarily funded by Stratford-on-Avon District Council but complemented by funding from the Department of Energy Security and Net Zero and the UK Shared Prosperity Fund.

The scheme will build on the success of the Home Upgrade Grant 2 scheme which saw 98 properties occupied by lower income households upgraded. The WHLG funding aims to improve the warmth and comfort of more of the worst performing homes across the District, whilst also reducing energy bills, carbon emissions and levels of fuel poverty.

If residents are eligible for the WHLG scheme, an assessor will visit the home to determine the best energy efficiency

Residents could be eligible if they are a homeowner or a private rented tenant, and if:

- They have a combined annual household income under £36,000 (savings are not assessed) or receive means-tested benefits

Other eligibility criteria could be available, please contact Act on Energy.

Appendix D – County Councillor Report

Council issues: Following the resignation of the previous Leader of the Council, Cllr George Finch of Reform UK was elected the New Leader of the Council. The vote was drawn between Cllr Finch and Cllr Roodhouse, LD, and as a result, Cllr Finch was elected by the Chair's, a member of Reform. casting vote.

Last week Cllr Finch held a press conference about the future direction of the Council. The Minority administration intends to focus on: SEND, potholes and safety.

HS2: The closure of the A423 between Southam and Ladbroke has caused major concerns to residents both within Ladbroke but also the wider community with the impact being felt from Southam through to Fenny Compton I have been working with both County officers and Sir Jeremy Wright for over six weeks to get a more rational road closure, but EKFB do not seem concerned about the impact of its closure on the local road network and residents. A simple solution of extending the road closure, with local access permitted, to include the access to Ladbroke would make a significant improvement but EKFB have refused to consider this proposal

Highways

Introduction of Enforcement Support for Phase 1 School Keep Clear Zones

As part of the Authorities ongoing commitment to improving safety around schools, parking restrictions will be actively enforced from this September 2025.

Uniformed officers will be patrolling designated school sites to monitor compliance, engage with drivers, and raise

awareness about the importance of safe and legal parking near schools.

To support this initiative, Penalty Charge Notices (PCNs) will be issued to vehicles found in violation of the restrictions.

Why Enforcement Is Necessary

Regular reminders are with parents and carers about the importance of safe and considerate parking near schools. However, some drivers continue to stop or park on restricted markings, such as "School Keep Clear" zones and double yellow lines.

While often unintentional, this behaviour can create unsafe conditions by reducing visibility, increasing congestion, and making it harder for children to cross safely.

Unfortunately, Warwickshire has seen a rise in traffic-related incidents involving *children near school sites*.

By introducing active enforcement, the Council aims to support safer travel for pupils, encourage responsible parking habits, and protect the wellbeing of the entire school community. Enforcement Measures Include: School Keep Clear Zones: • Vehicles parked in these restricted areas during operational hours will be issued a Penalty Charge Notice (PCN) of £70, reduced to £35 if paid within 14 days.

Director of Highways: The Council has now appointed a permanent replacement Richard Fenwick AS Director of Highways from the beginning of this July. Richard was recruited from Lincolnshire County Council.

I have already had a number of Teams meeting with Richard to discuss the local infrastructure. Shail Chohan remains as head of County Highways.

Changes to some of the teams have already been implemented.

The Devolution Whitepaper: There is no update on this issue. The County's position remains that the delivery of key and challenging services, adult and children's social care, highways and the WFRS can best be delivered across the County rather than being spilt into two, north and south, with the resulting duplication and increased investment in service delivery

Division issues: Concerns have been raised about the use of Hambridge by overweight vehicles, and as a result, an inspection has revealed some structural damage.

A new 4 tonne weight limit is being considered along with road narrowing's to prevent HGVs or large agricultural vehicles using it.

I have authorised expenditure from my delegated budget this year to resurface areas in Bishops Itchington and other villages. As this work needs to be done in school holidays, it is unlikely this will be done until the Feb 26 half term.

Flooding on both Long Itchington and Fenny Compton are still concerns and I am continuing to work the FRM teams to reduce flooding. We are still awaiting a report in Long Itchington, from Bloor Homes, on their findings and it is frustrating that it is taking so long. The FRM team have concerns over the feasibility of the "New Drain" from Ridgeway in Fenny Compton.

I have asked for details of the timing of this year's gully and drain cleaning schedule, and the results. The contractor has been pressed to supply them.

Road closure – Memorial Road FC. The behaviour of Severn Trent and its subcontractor have been unacceptable, and I have reported and had arranged the removal of un-permitted road closure signs twice, particular in relating to blocking access to the school.

ST have been told any closure must include the introduction of traffic management to Brook Street to allow it to be used in both Directions.

Warwickshire schools to gain safety boost from greater parking enforcement: Warwickshire County Council's ongoing commitment to improving road safety around schools will see parking restrictions actively enforced at a number of schools, starting from 1 September.
